Our busiest clinics use each DigniCap device they have for 2 or 3 treatments each weekday.

The demand for DigniCap around the globe has increased tremendously in recent months and we have seen increased awareness and interest especially in Asia and South America. We have added resources to our Global Sales team to respond to this trend and have also implemented a strategic plan to guide global sales efforts in the most effective and efficient manner. 
#### Life Science Day Presentation

Dr. Angad Deengar of Norwalk Hospital in Connecticut presented a poster highlighting impressive results of a retrospective study of DigniCap use at their facility tracking success by chemotherapy regimen.

Chemotherapy Regimen	Total patients	Successful Outcome	Percent Successful
Taxane-based only	54	43	80 %
Combination Anthracycline and Taxane	25	15	60 %
Anthracycline only	4	3	75 %
Non-Anthracycline or Taxane-based	7	7	100 %
