DigniCap Delta Update

FDA clearance is pending for DigniCap Delta, the next generation of The DigniCap Scalp Cooling System. Plans are progressing to launch the device in the United States and Europe as soon as all necessary regulatory clearances and approvals are received.

The DigniCap Delta provides significant improvements over the current DigniCap C3 model with a single patient unit for flexibility in tight spaces that is 54 percent smaller than the current unit. The intuitive interface provides up to 80 percent reduction in nursing time per patient infusion versus existing device, as well as other enhancements. DigniCap Delta also features a new single patient use cap system consisting of a flexible Cooling Wrap and an adjustable Thermal Cap.
