### Dignitana Leadership Efforts Prompt Landmark Legislation

On 10 May <u>HB3984</u>, a bill providing coverage for scalp cooling that Dignitana initiated in February with Texas State legislators, was passed in the Texas House of Representatives. The Bill now moves to the Senate Business and Commerce Committee to be introduced by Senator Angela Paxton. Once passed by the full Senate, the Bill then requires approval by Texas Governor Greg Abbott before being signed into law for the state of Texas.

Dignitana has been working on this initiative for several months with Texas State Representative Jeff Leach and legislative consultants. The company invited Paxman to join in supporting the legislation when Dignitana CEO William Cronin and other scalp cooling advocates spoke at the bill's introduction on 16 April.

Dignitana is supporting similar initiatives in other states and will provide further information when available.
